Be an informed voter. Do the candidates who want your vote also support the issues you care about? How to find out? Ask them! Attend voter forums. Research their websites.

- All state representatives are up for election; only some state senators are.
- Candidates who filled out a questionnaire from The Arc of Washington are noted under "Candidate Response." If yes, link takes you to their response.
- Didn't fill out the questionnaire? Email them the link and ask them to: https://arcwa.org/content/uploads/sites/35/2020/06/Legislative-questionnaire-2020.pdf. Explain it will help you make an informed choice.
- You can email about any issue you care about. Find out how they would represent you.
- We also noted which incumbents attended our 2019 King County Legislative Forum for Developmental Disabilities. That indicates some familiarity with issues that affect people with intellectual or developmental disabilities.
- Advocacy tip: If you are contacting a candidate about a campaign matter (such as asking them to complete a questionnaire), use their campaign contact information. If they hold office, they cannot use their office email addresses or phone lines for electioneering.
