

Wings for Autism[®] is an airport rehearsal designed for individuals with an autism spectrum disorder, their families and aviation professionals. The program is designed to alleviate some of the stress that families who have a child with autism experience when travelling by air. The program also gives airport, airline and Transportation Security Administration (TSA) professionals the chance to observe, interact and deliver services in a structured learning environment.

Wings for Autism® provides families with the opportunity to practice the following:

- entering the airport
- obtaining boarding passes
- going through security
- boarding a plane & taxiing around the airport

Wings for Autism® takes place on Saturday, October 19, 2019 with an average of 20,000 people passing through the airport during the 4-hour period. The visibility attracts an enhanced customer base, appreciation and respect from your employees and members of your community and goodwill from individuals who value businesses that are good corporate citizens giving back to their community. The Arc of King County is a local AND national organization serving individuals with developmental disabilities. A variety of sponsorships are available.
