

## Childcare support, Inclusion Academy

### Position Description

Part-time child-care providers for our Inclusion Academy.

- Must be great with kids
- Have basic first-aid knowledge
- Be willing to problem solve
- Be willing to clean up small messes associated with group child-care

Interest in learning the curriculum for [Special Olympics Young Athletes](#) is a huge plus! (We can reimburse for time spent training.) Experience working with children with developmental delays or behavior supports is a plus. This is a great opportunity to supplement your income with a short-term commitment.

We are looking for three providers – a lead organizer and 2 assistants – to provide child-care to a group of children ages 2 and up while their parents are taking a class; our targeted child to adult ratio is 5 to 1.

For the lead position, we are looking for someone who has experience and ideas for creating a structured play environment and who can problem solve and help direct assistants.

For the assistants, we are looking for responsible, experienced providers who can play with kids and keep them safe and active. Must be comfortable working in a group care environment.

### Hours and Compensation

Minimum of nine Saturdays from February to early April; hours are either 5.5 per day or 4 per day, depending on the date. Location is in North Seattle at a nonprofit organization in a quiet neighborhood.

Lead provider: \$20 to \$22 an hour depending on experience

Assistants: \$18 an hour
